

Terms and Conditions...(please read carefully)

CONSIGNMENT DEADLINE WEDNESDAY, JUNE 1, 2011

ALL CONSIGNORS MUST BE A CURRENT MEMBER OF AQHRA

Entry Fee: \$200 per Yearling + \$10.00 GST = \$210.00 (Canadian Funds only) non-refundable

Commission Rate 6% on all yearlings (including repurchases, buybacks, passouts, etc.)

Starting / Upset Bid \$500

All GST derived from the Canada Quarter Horse Cup Auction will be remitted to the CC&RA by the AQHRA (GST# 86750 9333)

The consignor agrees to guarantee the horse to be sound as represented. The sales committee reserves the right to remove the horse from the sale if it is proved to be unsound or in poor condition at the time of the sale.

All horses must have an appropriate manifest.

There will be **no refund of entry fees** on horses withdrawn from the sale.

Quarter Horse Yearlings entering the sales ring in the yearling portion of the sale are eligible for the Canada Quarter Horse Cup Futurity and Derby provided that the first payment is made to the Futurity.

Conditions of the sale are as listed in the sales catalogue. The decision of the sales committee will be final in all matters.

No registration papers will be released for pass outs etc. until the 6% commission has been paid.

The consignor agrees to supply AQHRA with the following:

- >> Original Registration Papers
- >> Filled out and signed AQHA Transfer Form
- >> Signed Consignment Contract
- >> Proof of Parentage Verification
- >> Proof of Coggins Test
- >> Appropriate Provincial / State Manifest

I understand that the AQHRA will use reasonable efforts to verify the financial responsibility of the buyer of each Animal and that possession of each Animal sold will be given to the buyer against receipt of payment after satisfaction of AQHRA's settlement procedures. I agree that if the sale of any Animal is not consummated by reason of default of the buyer or otherwise, AQHRA will not be liable for the purchase price of the Animal. The AQHRA will attempt to assist in the collection of the purchase price of the Animal, in the recovery of the animal or in the resale of the Animal at the Sale or by private treaty in the event that I might request assistance.

I, the consignor, understand and agree that I am the sole guarantor of the accuracy of all catalogue information regarding the horse(s) I have consigned. I agree to review such information prior to the sale and report any inaccuracies or omissions to the AQHRA Program Coordinator. I agree that AQHRA will not be held liable for any damages, actual or consequential, arising out of any such failure. I agree that the sole liability of the AQHRA, should it fail to catalogue any horse consigned, shall be to return the entry fee for such horse.

I have read, approved and agree to be bound by the foregoing terms and conditions as provided by the AQHRA's consignment contract.

IMPORTANT ITEMS TO REMEMBER

- > All purchases must be paid for by cash or cheque at time of sale
- > Alberta Stallion Service purchasers will also receive one (1) non-transferable PAID ENTRY into the Alberta Stallion Stakes Futurity if they purchase the service at the stallions standing or reserve price.
- > The first payment for the 2012 Futurity must be made in order for a yearling to be eligible for the 2012 Futurity and 2013 Derby.
- > Payment schedules for the 2012 Futurity and the 2013 Derby will be announced at a later date
- > Horses can begin moving into the Sale Pavilion on Friday, September 2 at 12:00 noon
- > All horses must be removed from the Sale Pavilion by Sunday, September 4 by 5:00pm
- > All persons attending this sale do so at their own risk
