

ALBERTA BRED QUARTER HORSE DECLARATON FORM

I/We understand that falsifying foaling information and/or this declaration is considered a serious offence by the Alberta Quarter Horse Racing Association, American Quarter Horse Association and Horse Racing Alberta. If the declared location of foaling is questionable, the onus will be on the Breeder/Owner to provide further documentation (breeding records, invoices, import papers, witness statements, etc.) to verify eligibility for Alberta Bred incentives. I/We also understand that should I/We fail to provide adequate documentation (if requested), the horse shall be ineligible for Alberta Bred races or incentive programs. The Owner, Trainer, Breeder and Stallion Owner shall relinquish all rights to receive Alberta Bred bonus or prize money and any award(s) derived from having Alberta Bred status if accreditation is not obtained. Registration papers will be stamped "Accredited Alberta Bred" upon approval.
