▪ All Breeding Stallions must have the five panel disease test results on file with AQHA as per AQHA Rule REG108.5.

1. A photocopy (front and back) of the Original or Replacement Certificate of Registration showing correct ownership.
2. Copies of any applicable lease forms.
3. List of partners in partnership, syndicate or corporation if applicable.
4. The required stallion nomination fee (see fee schedule).
5. If not yet acquired, include AQHRA Membership Application(s) and applicable fee(s).

**PROGRAM RULES**

1. The registered owner(s) or Lessee(s) of the stallion must be a member (single or family, and other as required) of the AQHRA.
2. Submit completed Alberta Stallion Stakes Sire nomination form.
3. Stallions must stand in Alberta for the entire breeding season.
4. An annual fee of \$200 per stallion per year is required to nominate the stallion. The fee must be postmarked on or before February 15th of the breeding season year. After February 15<sup>th</sup>, a fee of \$300 must be postmarked on or before July 1<sup>st</sup>.
5. No enrollment of Stallions after July 1<sup>st</sup> of the breeding season year.
6. If enrolled on or before Feb 15<sup>th</sup>, advertising & marketing as sponsored and directed by the sole discretion of the AQHRA is included (ie Stakes Book, Website etc)
7. All monies collected from stallion owners will go towards purses and promotion of the Stallion Stakes program.
8. Foals do not have to be born in Alberta to be eligible to participate. AQHRA recommends that all owners foal their mares in Alberta to take advantage of the “foaled in Alberta” owners/breeders bonus incentives.
9. It is the responsibility of the stallion owner/lessee to notify the AQHRA in writing if the stallion becomes deceased, is no longer breeding or changes ownership.

**MANDATORY DECLARATIONS**

1. I/We declare that the information concerning the principal residence of this stallion is correct and that the stallion shall be made available for inspection by the AQHRA at any time during the breeding season.
2. I/We understand that should I/We fail to provide documentation as requested the stallion may be ineligible for Nomination to the Stallion Stakes program and any fees paid will be forfeited.
3. I/We understand the AQHRA may share my/our contact information (including by electronic means) for the purpose of administering AQHRA race and bonus incentive programs.
4. **The AQHRA reserves the right to amend, cancel or alter the program and/or make changes to the program of any nature and kind whatsoever, and the signatories of this form hereby agree to be bound by such changes as communicated by the AQHRA.**
